Leisure Parts 4u – Trade Account Terms & Conditions

1. Trade Account Eligibility

Trade accounts are available to approved business customers only. Approval is at the sole discretion of Leisure Parts 4u and may be withdrawn at any time. All information provided must be accurate, complete, and kept up to date.

2. Pro-Forma & Credit Accounts

All new trade accounts will operate on a pro-forma basis unless otherwise agreed in writing. Credit facilities may be offered subject to satisfactory trading history and/or credit checks. Leisure Parts 4u reserves the right to amend, suspend, or withdraw credit limits at any time without notice.

3. Payment Terms

Standard credit terms are 30 days from invoice date unless otherwise agreed in writing. Payments must be received in full by the due date. Late payment may result in account suspension, interest charged at 8% above the Bank of England base rate, and recovery of reasonable costs.

4. Pricing & VAT

All prices are exclusive of VAT unless stated otherwise. Prices are subject to change without notice. Quotations are valid for 30 days unless otherwise agreed.

5. Orders

It is the customer's responsibility to ensure all product details and specifications are correct. Special order, bespoke, or non-stock items cannot be cancelled or returned once confirmed.

6. Delivery

Delivery times are estimates only. Orders may be delivered in multiple consignments. Risk passes to the customer upon delivery.

7. Damage & Claims

Goods must be checked on delivery. Any damage or shortages must be reported within 48 hours with supporting photographs.

8. Returns

Returns are accepted only with prior authorisation. Stock items may be subject to a restocking fee. Special order items are non-returnable.

9. Retention of Title

Goods remain the property of Leisure Parts 4u until paid for in full.

10. Account Suspension

Leisure Parts 4u may suspend or terminate accounts where payment terms are breached or misuse occurs.

11. Liability

Leisure Parts 4u shall not be liable for indirect or consequential losses or delays beyond its control.

12. Governing Law

These terms are governed by English law and subject to the jurisdiction of the courts of England and Wales.

13. Acceptance

By applying for and using a trade account, the customer confirms acceptance of these Terms & Conditions.
